#### What is the Friend of the Court?

- ➤ The Friend of the Court is a Title IV-D agency created by the Social Security Act
- Wayne County is a combined Prosecuting Attorney and Friend of the Court Office
  - Prosecuting Attorney establishing paternity and support
  - Friend of the Court enforcement and modification of support, custody, and parenting time

#### How to start a case

- A custodial party may seek assistance from the Department of Health and Human Services (DHHS) for children living in their household
- When a custodial party fills out the application to receive assistance from DHHS/State of Michigan, they also are authorizing the State of Michigan to seek reimbursement for that assistance from a noncustodial parent
- DHHS submits a referral to the Office of Child Support. The Office of Child Support's support specialists interview the custodial party and make a determination of what type of case it is and the county it should be referred to.
- The Office of Child Support will then send a CAR (court action referral) to the appropriate county's prosecutor's office. Here, in Wayne County, we would receive the referral within Wayne County Friend of the Court's Case Establishment Department.

#### How to start a case continued ...

- A case can be started by either parent/guardian to establish paternity, child support, custody, and/or parenting time
- The parent or child do not have to receive public assistance to apply for services
- You may apply online with MiChildSupport, complete and mail a IV-D Child Support Services Application/Referral – DHS 1201 form, or call (866) 540-0008

### The Life Cycle of a Case

\* About 80% of the cases in Wayne County are Paternity (DP) or Family Support (DS) cases started by DHHS.

Party seeks assistance from state for care of child (DHHS)

DHHS sends the case to the Office of Child Support

Prosecuting Attorney (in Wayne, part of the FOC office) starts a case to either establish Paternity or set Support

### The Life Cycle of a Case

Complaint
& Ex Parte Order for Genetic Testing Filed

Defendant Served

Defendant files Answer to Complaint or Not

Hearing scheduled for Parties to come to Court to determine custody

Order of Filiation or Order of Support
Entered
(Both include child support)

Parties to come to Court to determine custody, parenting time and support

### How to establish paternity

There are four ways to establish paternity:

- ➤ The mother and alleged father voluntarily sign an Affidavit of Parentage and file it with the State of Michigan's Vital Records Department.
- ➤ A paternity case (DP) is filed, and an Order of Filiation is entered with the Court. The order could be entered after genetic testing, default, or consent. The case shall be filed in the county where the mother and child resides.
- Marriage child is conceived or born during a marriage (regardless if husband is the biological father, husband is the legal father).
- Adoption Court grants an Order of Adoption

#### How to enforce child support

- ➤ In person FOC show cause hearings temporarily suspended due to COVID-19
- Request for show cause will be reviewed for potential employment and income withholding, and remain on list for show cause
- > Other enforcement remedies in full effect
  - Automatic enforcement: credit reporting, tax intercepts, passport restriction
  - ➤ Income withholding and license suspension may be requested by contacting FOC in writing, calling the Call Center, or scheduling a virtual customer service appointment

### How to enforce parenting time

#### Specific Parenting Time Order

- \* If you have a specific order for parenting time and the other party is refusing to comply, the Friend of the Court will enforce the parenting time Order.
- Request for Parenting Time or Custody Enforcement (form 4052) <u>www.3rdcc.org</u> \*No fee

#### No Specific Parenting Time Order

- \* If you do not have a specific parenting time order, you will need to get a specific order before the Friend of the Court can enforce parenting time.
- Motion to Change Parenting Time (form 4031)

# How to manage arrears and/or payments

- Payers may apply for discharge of state-owed arrears. Arrears Forgiveness Program Application available at <a href="https://www.3rdcc.org">www.3rdcc.org</a>.
- ➤ Payers who are working and only owe money to the state may file a Motion for Payment Plan Form 4100. Once payer complies with payment plan, balance of state-owed arrears is discharged.
- Payee may consent to waive arrears owed to him/her by stipulated order or by motion – Form 4124.
- If income withholding is too high, payer may file a motion to lower payments Form 4124.
- ➤ If parties marry <u>after</u> case is finalized, they may submit a Stipulation to Abate Support Based Upon Marriage Form 4572.

# How to file a new case, motion or objection continued ...

- Filing fee must be paid or waived BEFORE filing a new case or motion if filing by fax or email. There is no filing fee for objections.
- All emailed pleadings filed MUST be in PDF format.
- When filing a Motion, the Motion, Brief, Notice of Hearing and Proof of Service can be filed as one single document. All other documents **MUST** be filed as separate PDFs.
- ➤ If you are faxing in your pleadings, do **NOT** attach a cover sheet or letter.
- ➤ If your filings are rejected, you **MUST** resubmit **ALL** filings, not just the rejected portion.

# How to file a new case, motion or objection continued ...

- ➤ If you file a motion by fax or email you will need to monitor the case on <a href="https://www.3rdcc.org/odyssey-public-access-">https://www.3rdcc.org/odyssey-public-access-</a> (opa) to determine when the motion has been filed with the Clerk's Office.
- Once the motion has been entered on Odyssey, you must fill out either a <u>Family Domestic Praecipe</u> (used when motion will be heard by the Judge) or <u>Friend of the Court</u> <u>Praecipe</u> (used when motion will be heard by the Referee) to ensure your motion is scheduled.

- Hearing will be held over Zoom

# Third Judicial Circuit Docket Directive 2013-26 Domestic Relations Actions

- Must have requested Title IV-D services and have an open FOC case to have a hearing before referee. If opted out of FOC services, must reopen FOC case.
- If more than one motion is filed in the same case at the same time, only one motion fee will be charged.
- Motions regarding parenting time, child custody, or child support issues must attach a copy of the most recent order regarding the issue raised in the motion
- ➤ All motions to set aside paternity and prejudgment motions on state-initiated cases go before Presiding Judge
