The POWER Act (Pro Bono Work to Empower and Represent Act of 2018, P.L. 115-237) requires each judicial district in the Federal Judiciary to encourage lawyers to provide pro bono services to survivors of domestic violence, dating violence, and stalking.

DOMESTIC ABUSE DEFINED

- A purposeful pattern of physically, psychologically, sexually, or emotionally abusive actions;
- Carried out over time;
- With the aim of controlling an intimate partner

HOW DOES ABUSE START?

- Extremely attentive, flattering
- Jealous of interactions with others
- Isolation
- Intense interest in activities
- Angry if "late" from activities, work, school, third degree
- Controls all actions, makes all decisions

WHY DOESN'T A VICTIM LEAVE?

- Lethality
- Concern for chidren's welfare without buffer
- Financial dependence on abuser
- Lack of housing
- Inability to afford legal assistance
- Fear of losing custody
- Isolation leading to lack of family/friend support
- Acceptance of the blame for abuse
- Hope that abuser will change
- Lack of self-confidence caused by years of listening to belittling comments
- Religious or cultural constraints



PRO BONO ATTORNEYS

Proactive efforts should be made available in all forums to provide pro bono legal services and eliminate the violence that destroys lives and shatters families. Pro bono assistance can help fill this need by providing not only legal representation, but also access to emergency shelter, transportation, and childcare. P.L. 115-237 cites the ABA Model Rules of Professional Conduct commentary stating that "every lawyer, regardless of professional prominence or professional workload, has a responsibility to provide legal services to those unable to pay, and personal involvement in the problems of the disadvantaged can be one of the most rewarding experiences in the life of a lawyer." A dedicated army of pro bono attorneys focused on this mission will inspire others to devote efforts to this cause and will raise awareness of the scourge of domestic violence, dating violence, sexual assault, and stalking throughout the country.
