



With or without counsel, an asylum seeker has the burden of proving that they meet the definition of a refugee.

#### WHAT IS ASYLUM?

#### A person who is

- unable or unwilling to return to their home country, and cannot obtain protection in that country,
- due to past persecution or a well-founded fear of being persecuted in the future
- on account of
- race, religion, nationality, membership in a particular social group, or political opinion.

### **ELEMENTS OF ASYLUM**



Persecution - Defined as "a threat to the life or freedom of, or the infliction of suffering or harm upon, those who differ in a way regarded as offensive."



Government Unable or Unwilling to Control Persecutors - Persecution is inflicted either by the government or by persons or organizations the government is unable or unwilling to control.



On Account of – Persecution must be on account of an enumerated ground. It is not the persecutor's subjective intent but rather the objective persecution. It requires an examination of the persecutor's views of applicant's actions or lack of action.

## PROTECTED GROUNDS

#### **Political opinion**

Requires an active specific opinion or belief. May encompass more than electoral political and formal political ideology or action.

#### Race

Racial categories tend to combine various cultural groups into larger identities—be they defined by the groups themselves or (as in most cases) by other people.

#### **Nationality**

Can include national ethnic or linguistic group or national minority with a dominant national group or even national majority with a dominant minority group

#### Religion

Understood broadly to include newer or smaller systems of sincere beliefs and may also includes converts.

Particular Social Group (continued)

# PARTICULAR SOCIAL GROUP

## 1. A group of persons who share a common, immutable characteristic:

- This characteristic cannot be changed, or it is so fundamental to their identity or conscience that they should not be required to change it or cannot change it.
- Examples include sexual orientation, family ties, gender, or past experiences (e.g., domestic violence).


#### 2. Social distinction (or visibility):

The group must be perceived as distinct by society in the applicant's country. This doesn't necessarily mean physical visibility but social recognition.

#### 3. Particularity:


 The group must be clearly defined with specific boundaries. It cannot be overly broad or amorphous. For instance, "young men in danger of gang recruitment" may not meet this standard, while "former child soldiers from X country" might.

EOIR allows for limited appearance for document assistance before the immigration court (EOIR-61).



They do not have the obligation to appear in court on behalf of the pro se respondent and has no ongoing responsibility.
