You **MUST** do the following or else your filing will be rejected or delayed:

- All emailed pleadings filed **MUST** be in PDF format.
- When filing a Motion, the Motion, Brief, Notice of Hearing and Proof of Service can be filed as one single document. All other documents **MUST** be filed as separate PDFs. This includes:
 - **Fee Waiver**
 - Receipt
 - Proposed Order (each order **MUST** be its own PDF)
 - Complaints, and include each of the following as their own PDF:
 - Verified Complaint
 - **Confidential Case Inventory**
 - **Certificate on Behalf of Plaintiff**
 - UCCJEA Affidavit
 - **Verified Statement** (**MUST** also send to FOCCOpies@3rdcc.org)
 - **Application for IV-D Services** (**MUST** also send to FOCCOpies@3rdcc.org)
 - Copy of Paid Filing Receipt
- If you are faxing in your pleadings, do **NOT** attach a cover sheet or letter.
- If your filings are rejected, you **MUST** resubmit **ALL** filings, not just the rejected portion.
- Your filings must comply with all statutes and court rules, just as if you were filing in person. For example, the Uniform Child Custody Jurisdiction Enforcement Act Affidavit must be attached with new filings and verified pleadings must be signed by the party.

Filing Fees

- [Fees for Filings must be paid prior to emailing or faxing the filing](#).
 - Parties can pay filing fees at www.govpaynow.com and use the code 6223.
 - A copy of the GovPay receipt must be included with the filing.
 - If filing a new case, use the Plaintiff's last name for the case number on GovPay.
- If a party is requesting a [Fee Waiver](#), the party must submit the fee waiver form first. The party must wait for a reply from the Clerk before submitting the Filing. A copy of the approved fee waiver must accompany the Filing.

Emergency Filings

- Emergency filings **MUST** be marked as Emergency on the first page of the filing.
- Emergency filings **MUST** have the [Emergency Filing Fee Cover Sheet](#) attached.
- Once the fee is paid or the fee waiver form is approved, submit the pleadings via email to emergency@3rdcc.org.
- The pleadings will be filed with the County Clerk and forwarded to the Emergency Judge for review.
- If there are problems or deficiencies with the pleadings, you will be contacted.
- Upon the Assigned Judge's review, you will be provided a copy of the Order that is entered.

Non-Emergency Filings

- All Non-Emergency Filings shall be emailed to filings@3rdcc.org.
- Once the document is filed and loaded into Odyssey, a copy will not be sent back to the filing party.

New Case Filings

- For new cases, once the case has been started, you will receive an email from the clerk. Once you have received that, you must produce your own summons:
 - Go to eSummons on www.3rdcc.org
 - Follow prompts
 - The summons will be available to be created and printed after the filing has been accepted by the County Clerk. The summons shall be served in accordance with court rules.

Motion Hearing Dates

If you are filing a Motion, whether to be heard by the Judge or by the Friend of the Court Referee, you will need to monitor the case on [https://www.3rdcc.org/odyssey-public-access-\(opa\)](https://www.3rdcc.org/odyssey-public-access-(opa)) to determine when the Motion has been filed.

Once the Motion has been filed, you will need to fill out either a [Family Domestic Praecipe](#) (used when Motion will be heard by the Judge) or [Friend of the Court Praecipe](#) (used when Motion will be heard by the Referee) to ensure your Motion is scheduled.

If you need assistance determining which ePraecipe to use, please review the [Domestic Relations Docket Directive](#) to determine if your Motion shall be heard by the Judge or Referee.

Once you have completed the ePraecipe, you will receive a completed copy back with your hearing date on it. Please note that the final hearing date may be different from what was requested on the ePraecipe, due to Court availability.

Personal Protection Order Filing Instructions

Due to the State of Emergency as a result of the COVID-19 health crisis, all filings for Personal Protection Orders (PPO) will be done via email at this time. Due to limited staffing, please know that your paperwork will be processed as soon as possible, in the order in which it is received. If you are in an emergency situation, dial 911 or contact your local police department. If you need assistance completing these forms, contact First Step Advocate at (734) 756-0508 or their 24 Hour Helpline of (734) 722-6800, Domestic Violence Advocacy Project- Americorps at (313) 334-7922, Lakeshore Legal Aid at (888) 783-8190 or William Booth Legal Aid Clinic at 313-361-6340 or visit www.wblac.org.

PLEASE NOTE THAT THE EMAIL ADDRESS YOU USE TO SUBMIT YOUR PETITION FILING WILL BE USED FOR COMMUNICATION WITH THE COURT. IF YOU HAVE SAFETY CONCERNS, PLEASE ENSURE YOU ARE USING A SECURE EMAIL ADDRESS.

Step 1: Complete the necessary forms. You will find the forms at www.3rdcc.org or you can click on the links below. Please fill out all forms completely.

Step 2: The County Clerk will process and file the Petition and forward it to the PPO Director for review. If any additional information is needed, you will be notified **at the email and/or phone number you provided.**


Step 3: The PPO Director will forward the Petition to the Judge for approval or denial. Once the Judge approves or denies the Petition, you will receive a copy of the Order approving or denying the Petition from the Clerk.

Step 4: If the Petition is granted, the Court will transmit the Petition to the Michigan State Police for entry into the LEIN system.

Step 5: If the Petition is granted, you will need to serve the Petition and Signed Order on the Respondent and file a Proof of Service with the Court. See [instructions here](#) on how to serve your PPO.

 - You want an order to restrain another person over the age of 18
 - **AND**
 - You are married to the person you want restrained, **OR**
 - You are not married to the person you want restrained but you live with or have lived with him or her and he or she is not your unemancipated minor child; **OR**
 - If you and the person you want restrained have a child in common even if you were never married to one another or never lived together; **OR**
 - If you and the person you want restrained have or had a dating relationship.
